



Non-Resident Golf & Tennis Privilege 2020 Season

Manchester Country Club is again pleased to offer a Non-Resident Golf & Tennis Privilege for the 2020 golf season. This program is designed for those who do not reside in Vermont and do not own property in the Manchester area. For seasonal visitors the privilege offers a full access during a 30 or 60-day playing window. For those who reside outside the Manchester area, the privilege offers season long MCC access. In both cases the privilege provides a great opportunity for those who want to enjoy the benefits of life at Manchester Country Club, but are not in the local area enough to justify a full golf membership. You will find that MCC offers more than a great golf experience as it enhances the social life of the entire family. We look forward to welcoming you to MCC!

Privilege Overview

- Unlimited rounds of golf with no time of day restrictions
- Full use of all Club facilities: practice range, short game area,, tennis courts and restaurant (The Beech)
- 7-day advance tee time reservations via the Club website for you and invited guests
- Access to clinics and lessons from staff of PGA-certified pros
- Welcome at all dining & social functions: weekly Twilight dinners, holiday Lobster Bakes, Opening Cocktail Party...and more
- Eligible to compete in the Member-Member, all Member-Guest events, Twilight League (substitute)
- Eligible to participate in the Men's League and Women's Golf Association
- Locker, bag & push cart storage programs available
- Full charging privileges to your Club account
- Ability to pay dues over multiple months

Eligibility (must meet both of the following conditions):

1. Applicant(s) may not own any type of property **in Vermont** within 50 miles of MCC
2. Applicant(s) **is eligible** if property owned is within 50 miles of MCC but out-of-state (northern MA or eastern NY) **OR** if the applicant(s) are seasonal renters/visitors who are in the Manchester area for a continuous period during the season

Privilege Limitations & Notes

- Seasonal visitor specific notes:
 - The maximum playing window is 60 days (or 30 days for the single month option). Start date for play window is first day of play. MCC requests that players notify MCC before start of first round.
 - Dues will not be pro-rated for stays of less than 60 (or 30) days
 - The privilege does not offer any ability to extend beyond the approved play window
- For a Single Non-Resident privilege holder, clubhouse access for card/game playing by a spouse requires purchase of a Tennis & Social Privilege
- For Club events & social functions requiring advance registration, priority will be given to full MCC members
- Full season privilege holders are automatically enrolled in our Hole-in-One Insurance (\$25) at the start of each season and in the MCC Greens Club (Capital Improvement Fund) which involves a small monthly (Apr-Sep) contribution. All net proceeds are earmarked for the Club's capital improvement initiatives. You may opt-out of either of these important MCC programs without penalty.
- All Non-Resident Privilege holders are also asked to support our traditional Employee Appreciation Fund through a one-time end of season contribution to recognize the services provided by all staff members during the year
- Privilege holders will not own stock or have voting rights at MCC
- Prospective privilege holder applications will be reviewed by the Membership Committee. MCC reviews the right to reject an individual's application for participation in the program.
- Dues are subject to Vermont sales tax.

Single (60 day): \$2100 dues+\$150 food minimum; (30 day): \$1400 dues+\$100 food minimum
Family (60 day): \$3150 dues+\$300 food minimum; (30 day): \$2100 dues+ \$200 food minimum
